## A MULTIDISCIPLINARY STUDY OF FICTION WRITING

## by Anthony Bloor

How do novelists create their fictions? Can literary theory help us to understand practice? What sort of mental work is involved in fiction writing? This book sets out to answer such questions, and its premise is that we can learn about a complicated process by building a model of the process; its goal is a model of fiction writing. Bloor begins by discussing the concept of a model of writing; then he introduces the kinds of models that are used in teaching, research, and the design of software tools for writers. He approaches the subject in an investigative fashion, moving on to examine models of writing in detail; these include behavioral, cognitive, and linguistic varieties. He then defines a basic model, which encapsulates the findings of empirical research into writing behavior. To develop this basic model into one of fiction writing, Bloor turns to Saussure's view of language as a system of signs, and pursues the idea that semiology and literary theory can be used to develop theories of writing as well as of reading. He discusses work by theorists such as Jakobson, Genette, Todorov and Barthes, and concludes by presenting a hypothesis about the ways in which fiction writers create meanings.
